

# S INFORMATION LITERACY & TECHNOLOGICAL AGILITY (ILTA)

## Shared Competencies Assessment and Actions | Institutional Effectiveness (IE)

### Assessment Process:

In the fall 2023 semester, faculty (re)designed a specific assignment or series of assignments that aligned with the ILTA rubric. In the spring 2024 semester, faculty scored the assignment(s) with the ILTA rubric, producing the results. The ILTA rubric included four performance levels: 0(Not Evident), 1(Emergent), 2(Developing), 3(Exemplary). Faculty were asked to score as at least 75% of the rubric using their (re)designed assignment(s). In total, **529 student artifacts** were collected and scored.

### Criteria for Success:


**70% of student assignments achieve a rubric score of 2 or higher.** This criterion allows the University to see what students are doing well in as well as where improvement is needed. It also helps the University identify teaching/learning professional development opportunities for faculty.

### Result Insights:

The campus-wide assessment found students were meeting the criteria of success for all indicators **except 6.2 and 6.3**. When the data for these indicators were broken down by class standing, it showed that first year students met the criteria whereas **sophomores, juniors, and seniors did not**. This suggests students are not retaining these skills over time. Courses and experiences tagged with ILTA can reinforce these indicators to address the learning gap.

### Actions:

- **Faculty Support** - The CTLE, IE, and SU Libraries co-sponsored a faculty development session: Easy Ways to Boost Students' Information Literacy in Any Class.
- **Time for Assignment Design** – IE will host six assignment design sessions throughout May 27-29<sup>th</sup> where faculty can (re)design assignments to align with the Shared Competencies rubrics.
- **Opportunities for Students** - SOURCE and the SU Libraries launched URP 100: Information Literacy and Research Strategies.
- **School/College/Division ILTA Initiatives:**
  - IE is collaborating with CUSE Works to assess how well students are learning the Shared Competencies in campus jobs tagged with the Shared Competencies.
  - IE hosted mini-assignment design sessions in spring 2025 for faculty teaching ILTA tagged courses in A&S and iSchool.
  - Kudos to Whitman – Prior to the release of the ILTA data, SOM offers students an information literacy certificate to through the IMPRESS program.
